New Business:

Louis Plude gave details for Christmas in the Square. It will take place November 30, 2024, from 4-7pm. Santa and cookie decorating will be at Lakefront Living during this time frame. Pleasantville High School Choir will be singing carols 6-7pm. The lighting of the tree will be at 6:30pm. Smokey Row will be providing hot chocolate. Webb Shadle Library will be making popcorn provided by Peoples Bank. They are looking for financial or actual donations for cookies. Thanks to the Pleasantville Youth Initiative they will have a PA system available this year. They would like the Mayor or Council members to make an introduction. Louis asked if the Grinch would be available? He is also asking that downtown businesses put up lights. It would be great to get the town to light up their houses also. He will be in touch with public works to check on the lights and when they can get them up. After a short discussion with Interim Chief Eysink, it was decided that road closure would be safest during the celebration. Motion by Hurt, seconded by Koehn to approve street closure at entry points of Jefferson/Monroe, Washington/Monroe, Jackson/Washington and Jefferson/Jackson on November 30th from 4-7PM. All voting in favor, motion carried.

Hurt confirmed with Public Works Director, Shawn Breazeale that Des Moines Dirt Worx completed the remainder of the items previously discussed. Motion by Hurt, seconded by Kohen to approve Pay App #8 to Des Moines Dirt Worx for the Shadle Park Pond in the amount of \$9157.39. All voting in favor, motion carried.

Deputy Clerk, April Schrader updated council that the health insurance renewal had a 3.01% increase from last year after decreasing 4.32%. We budgeted for 10% increase due to the unknown and decrease last year. No change in rates for dental or vision insurance. Motion by Hurt, seconded by Patterson to approve health, dental and vision insurance renewal. All voting in favor, motion carried.

Motion by Hurt, seconded by Patterson to approve Pay App#12 to Vanderpool Construction for W Pleasant St. and Hwy 5 Improvements Project in the amount of \$38133.73. All voting in favor, motion carried.

Discussion was made regarding monument repair/rebuild at the Shadle park entrance that was hit by school plow this past winter. Bob Gripp finished the work October 14th. Council member Hurt expressed that he was not pleased at the new location. Mayor Jurgens to discuss with the Pleasantville School on reimbursement to the city. Motion by Hurt, seconded by Patterson to approve payment to Bob Gripp in the amount of \$3000 for the monument repair/rebuild at Shadle Park entrance. All voting in favor motion carried.

Old Business:

Breazeale informed the council that he has been unable to meet up with Eli Miller to look at the storm water system repair on E Monroe. Motion by Koehn, seconded by Patterson to table the issue. All voting in favor motion carried.

Motion by Koehn, seconded by Patterson to adjourn the meeting. All voting in favor motion carried.
